- 1% 10 Net 30 days. Any invoices still open after 30 days will be considered past due.
- A \$12.00 charge may be assessed on any returned check.

Credit Application

Penn Valley Chemical may also require personal guarantees and/or other security interests.

Minimum orders/ Freight Charges/ Local Pick-up

- All orders, except for in-store pick-ups, will be charged \$5.00 freight.
- Orders under \$250.00 will be charged \$11.00 freight.
- Orders shipped via UPS will be charged the UPS fee plus \$5.00.
- All pick-up orders may placed by calling Penn Valley Chemical customer service at 215-855-1878 or 877-782-1878. A one-hour lead time ensures quick turn-around on pick-up orders at our facility.

- Professional, custom delivery is available in most markets for customers that support scheduled weekly/ daily route deliveries.
- Next-day delivery is available on stock items only.

Common Carrier

• Penn Valley Chemical is not responsible for paying Common Carrier accessorial charges, including: inside delivery, lift gate, hazardous material, sort and segregate, C.O.D. fees and construction site delivery.

Drop Ship Service

Damages
